## From Worship and Ministry: Upcoming Discussions and Events happening at Unami

February 25, 9:30am – Discussion to discern Unami's recommendations to the Friends Committee on National Legislation (FCNL) for priorities for the next legislative session. March 3, 11am - Unami Friends will continue our experiment with semiprogrammed Inter-generational Meeting for Worship on the first Sunday of each month. This will be a different worship experience then our usual meeting for worship. As worship begins, an adult Friend will share a short, prepared introduction (10 minutes or less) of a topic, theme or story that they have prepared and intend to be of interest and meaning to Friends of all ages. Intergenerational means "everything is for everyone!" All Friends are welcome to sit on the floor for the story and worship. There will be materials available (paper, crayons, pipe cleaners, stuffed animals etc.) that are conducive to inward listening. There will be no childcare provided – parents may accompany their child to one of the classrooms if they feel a need for some time away from the group. This experiment is a 'work in progress' and we encourage your feedback as we proceed through the year. We will need help. If you have interest in preparing some opening story or message for a future Inter-generational meeting for worship please contact a member of the Worship and Ministry Committee.

April 21, 9:30am – Discussion on Poverty by America by Matthew Desmond, he suggests that a lot of us benefit from poverty by consuming cheap goods, investing in the stock market either directly or indirectly, enjoying tax breaks like mortgage interest deduction and wealth transfer savings, and illustrates how we try to protect those investments. Desmond shows readers how our country does much more to subsidize affluence than to alleviate poverty. He challenges readers to become part of the solution.

We ask that you read the book (a copy is available at the Meetinghouse) and/or listen to an interview with Ezra Klein (link below.) We will discuss the contents of the book then move into brainstorming how we might individually and collectively become "poverty abolitionists."
